# Option 2: Webforms or Bulk submissions

Pawnshops and Credit Access Businesses who file by licensed location have the option of either filing by webform or filing a bulk report (all licensese at the same time) You can either choose to upload a file using the bulk submission method or complete your report using a webform. Once you start with one method then all licenses for your masterfile must be completed using the same method. Bulk submissions are helpful for large companies with many individual licenses. Everyone else should use webforms.



Only pawnshops should download a report template for bulk filings.
